At the invitation of the President of the National Council for Human Rights in Syria, a meeting of the General Assembly of the Council was held based on the exceptional internal rules daily 29-30 in Damascus

The internal and international developments in the Syrian issue were discussed, the development of the human rights mechanism, and confronting the challenges and serious violations of human rights and terrorism, which is increasing dramatically and has become a threat to the whole world.

And take the following decisions unanimously

First, the re-election of Qutayba Qasim Al-Arab as President of the Council for a new five-year term, starting from the date of the announcement

The president is the official spokesperson

Draws the general policy of the Council, supervises and approves the work of the Council, issues statements and decisions, appoints and dismisses advisors, represents the Council in all international forums, and concludes treaties and protocols abroad according to its vision of the general interest of the Council and its impact on human rights in Syria.

- Assigning Professor Shaalan Al-Sheikh to supervise the fact-finding committee in Al-Hasakah Governorate
- Assigning Mr. Qutayba Uqla to supervise the fact-finding committee in Aleppo Governorate
- Assigning Professor Muhammad Al-Ashqar to supervise the follow-up committee for field work
- Assigning Mr. Saad Fares Gerges to supervise the prison and detention center visit committee
- Assigning Ms. Diana Jabbour to supervise the Committee on the Rights of Women and Children
- Assigning Mrs. May Lebbs to supervise the Public Relations Committee for Communication with Civil Society
- Appointing Mr. Hossam Suleiman as an advisor to the Council
- Appointment of attorney Saad Al-Mushrif residing in Jordan as an advisor to the Council
- Emphasizing the confidentiality of the names of activists working in the field in all regions, especially the hotspots, out of concern for their lives

Sixteenth: The Speaker of the Council is assigned to make amendments to the internal system according to the new structural amendments
